Plaza del Sol is one of several new interim uses being sited by the Gresham Redevelopment Commission on the Cultural Marketplace (former Fred Meyer store) property in Rockwood at SE 187th & SE Stark St.

The plaza is the first piece of a recently approved interim use plan for the Rockwood Cultural Marketplace to transform the site with new sidewalks, paths, benches, a wildflower garden, play area, basketball courts, a food-cart area, and many other family friendly activities.

Rockwood might get that courthouse after all. A rebirth for Rockwood?



County commissioners approve scaled-down facility. Finding funding for the multi-million dollar project still an issue.

By unanimous vote

Multnomah County commissioners approved moving forward with a plan for a new courthouse in Gresham's Rockwood area Thursday, Oct. 1. If built - and it is still an *if* as the county has yet to approve funding for the \$17 million to \$21 million project -- the courthouse will replace Gresham's old facility on Powell Blvd. It's the first step toward building the courthouse in that the resolution approves spending \$800,000 on a "schematic design process" for the facility, which is to house two to three courtrooms and space for the county's district attorney's office.

The process is to include preliminary plans, a site plan, architectural specifications, cost estimates and updated budget details.



Once the process is complete, an oversight committee would review it before seeking approval from county commissioners to move forward with design and construction as soon as next spring. It's scheduled to open in spring 2012. **Reservations remain**

Some county commissioners did question building cost contingencies, how the county would pay for the building and whether it would be more cost effective to lease space instead of building a county-owned facility. "There are trade offs involved, we're looking at an \$8 million deficit next year," Commissioner Cogen said.

Decades in the making

For 25 years, Multnomah County has studied where to build a new courthouse in Gresham. In 2007, the county purchased 4.5 acres just south of SE 185th Ave and Stark St for a new justice center, complete with courtrooms and space for Gresham police and the county sheriff's office. But when the price tag more than doubled to nearly \$43 million and the economy collapsed, Multnomah County scaled down the facility to a simple courthouse in February. The county also decided – as a money-saving strategy – to move the project from Rockwood to county-owned land in downtown Gresham in May.

New plan

The 35,000- to 40,000-square-foot facility will house one large courtroom with space for a 12-person jury, a smaller courtroom for a six-person jury and medium sized flexible courtroom that could be used for after-hours community activities.

Plans call for continuing Southeast 185th Avenue, which now stops at Stark Street, through the site. The courthouse building would be where a closed KFC now sits south of Stark Street and west of where 185th will continue. A secured parking lot would be south of the courthouse with space for expansion farther south or to the east. Until demand creates the need for even more courtrooms, property for future expansion could be used as community gardens.

Rockwood resident Nick Kahl, D-Gresham, said the courthouse would not only provide a much-needed service to East County but could serve as an engine for economic development in Rockwood. "Rockwood could have a renaissance," said Kahl, a resident of the area. "It could see a rebirth. And for the people who live here this means a whole lot more than a courthouse." Reynolds rehires some laidoff teachers with extra funds from Legislature.

Finally some good news. District receives additional \$6.2 million in funding

Board votes \$2 million to rehire teachers, \$2 million for obligations. Places \$2.2 million in contingency fund.

Board votes to spend added millions now

A unanimous Reynolds school board voted to spend \$2 million to immediately hire back laid-off teachers in order to reduce class sizes.

Parents complained that students would suffer from a lack of attention and individualized instruction if the district stuck to its earlier plans to eliminate one of every four teaching positions and raise class sizes to 35 or larger at most grade levels.

The new smaller classes will give schools one teacher for every 27 students in the primary grades and one for every 30 students in grades three and higher.

The district has faced tough budget challenges this year as a result of past overspending.

In June, the board adopted a budget that required laying off more than 100 teachers, far more than in any other Portland-area district.

Fisher to leave post in June 2010, Nelson resigns from board

Superintendent to leave next June

Robert J. Fisher, superintendent of the Reynolds School District, will leave the post Jun 30, 2010.

On Oct 1, the Reynolds district board asked Fisher to stay through Jun 30, 2011. However, on Monday, Oct 12, Fisher notified the board that he was declining its request.

Fisher said he decided to leave because he felt discussions surrounding his possible staying on would only distract from the work needed to be done to address various district challenges.

Fisher was hired in Sep 2009 following the resignation of then superintendent Terry Kneisler amid concerns over budgeting practices.

The City of Gresham is in the process of hiring a consultant to assist in developing a comprehensive master plan for this expansion and it is expected that they will be in attendance at this meeting. This master plan process includes how the plan for the new expansion area will be integrated with the Nadaka master plan adopted in 2001 and may include revision of the 2001 master plan.

Metro Grant & Criteria for Development

In applying for Metro grant money this project is required to meet the following criteria:

- 1. "Re-nature" neighborhoods by increasing & recovering the presence and function of ecological features to protect water quality & plant habitat.
- 2. "Re-green" urban neighborhoods to enrich peoples' experience of nature and help strengthen a physical connection to the region's ecology.
- 3. Demonstrate multiple benefits for people & natural systems.
- 4. Demonstrate cost-effective ecological design solutions.
- 5. Increase the region's fish & wildlife inventory.
- 6. Restore and/or improve habitats of concern such as eligible lands identified under the land acquisition criteria for the program and/ or headwaters and confluences of the region's important urban stream and river corridors.
- 7. Improve natural amenities to provide universal access to the public.

These criteria were met in the Metro grant application that was also considered when obtaining funding from EMSWCD and the assistance of TPL. Under #3 some of the things to be included in this master plan are: create a community garden, community orchard, native plant nursery, nature-based play equipment, picnic facilities, etc.

In addition, benchmark #3 of the intergovernmental agreement with the City of Gresham requires "Revision of the master plan that identifies the future use of the site and directs the use of sustainable site development practices in order to improve the biological functions of the site." n


Nelsen bids farewell to Reynolds School Board
