It is likely that many of you have driven or walked by the Downtown Rockwood Project and noticed progress.

Well - you are right! Progress has been achieved! The [Downtown Rockwood](#) Project, formerly known as the Rockwood Rising project, has been on many of our long-term resident's minds for many years. It is a project that has been discussed for over a decade, and although took many steps to initiate the project, some setbacks, and some good old fashion patience, the fruit of many years of labor is now visible.



First, the new 50,000 square foot Innovation Hub has been built and opens this spring. It's called the Innovation Hub because so much of it involves the creation and adaptation of new skills and ideas.

Second, the long-anticipated Market Hall is currently being built and scheduled to open this fall. Soon, community members will be able to showcase their delicious multicultural foods and crafts to share with the entire community.

And this fall construction begins on the final mixed-use building featuring retail and commercial storefronts, mixed-income apartments and more.

If you have a free moment I encourage you to take a stroll and see the current progress.

The buildings look amazing and contemporary. ■

Albertina Kerr Housing Update

The Albertina Kerr Workforce & Inclusive Housing project continues to move forward.

Demolition of the old Wynne Watts school began on January 4th and initial site work was completed on January 21st. After a brief pause for a week while we closed financing, construction began in earnest on January 29th, and we expect to complete construction of the 150 unit four-story workforce apartment building on May 22, 2022 and will begin leasing and moving in tenants following.

Wilkes East Land-Use Update

Hello members of our Wilkes East Neighborhood Association. We are following several projects around our neighborhood. Here's an update on what's been happening since our last newsletter.

UPDATE: Albertina Kerr Workforce Housing, 930 NE 162nd Ave., Gresham, 97230: As you drive by NE 162nd near NE Holladay Street, you'll see that the Wynne Wyatt School building has been completely razed and the project is in full swing with excavation of the Albertina Kerr property. A temporary fence surrounds the project with careful attention to preserving standing fir tree at the northwest corner of the property. Construction vehicles are using a temporary access road from NE Holladay. Please use caution when using NE Holladay Street. This is development of a four-story workforce apartment building (100,548 gross square feet) with a total of 150 units, 146 dedicated residential vehicular parking spaces areas, children's play area and other associated site improvements. Construction should be completed by August of 2021.

UPDATE: Taco Bell, 2301 NE 181st Ave, Gresham, 97230: Proposed project is set at the off ramp of the interchange of I-84 and NE 181st Avenue is new construction of a 2049 SF Taco Bell Restaurant with drive thru. The overall size of the site is 30,330 SF that adjoins the Burger King restaurant and is adjacent to the Bridge-way Inn and Suites and the new "My Place" hotel being built.

There will be the maximum 28 parking spots and access will be from NE Wilkes Rd with reciprocal access agreements with Burger King and the Hotel. Additionally, there will be an ADA access ramp to NE 181st Ave. The Taco Bell "Tower" will be 24 feet tall and will be on the side of the freeway. Code Compliance: Working to Maintain Safe and Healthy Neighborhoods

The City of Gresham livability team assists property owners in resolving general nuisance issues in Gresham, including: abandoned vehicles; overgrown vegetation; graffiti; debris, garbage and junk; RV parking permits and more.

Report a Code Violation

Report online through [My Gresham](https://mygresham.greshamoregon.gov), the city's reporting website and phone application. Visit <https://greshamoregon.gov/mygresham> My Gresham ensures the concern is routed to the correct department to address the issue quickly. My Gresham's required reporting fields ensure that the City receives all the necessary information to open a case and provides communication between the reporting party and City staff. Call 503-618-2463.

Vehicle Case Process

Upon receipt of request and complete vehicle information, a case is created, and an inspector will do a first inspection to determine if the vehicle is violating city code. If violations are confirmed, the inspector will take photos and issue an impound notice explaining the violation and providing a deadline (24-72 hours depending on the violation) to correct the issue. If vehicle has not moved and violations are not corrected by the deadline, the vehicle will be towed.

Property Case Process

Upon receipt of request, a case is created, and inspector assigned based on geographic area. Through a series of inspections and notices, the inspector works collaboratively with the property owner to explain the violations and how to correct them. If the violations are not resolved after 6 weeks, the City issues civil penalties which escalate in amount for up to 6 additional weeks. If the violations remain unresolved after the civil penalties are issued, the City can correct the violations via an abatement warrant, the cost of which becomes a lien against the property.

In 2020, the livability team successfully resolved 97% of property cases before they incurred civil penalties. It is the City's goal to help property owners come into compliance early and collaboratively.

Help a Neighbor in Need

The City's *Neighbors Helping Neighbors* program connects community volunteers with neighbors with hardships to solve common code issues such as overgrown vegetation or low-hanging tree limbs.


For example, a volunteer may help a neighbor with disabilities by mowing his lawn to resolve the problem of overgrown grass.

Hazardous Spills, Who to Call?

Recently, we had a tow truck driver bring our disabled car home to our driveway. When the tow truck driver was unloading the car from the flat bed, a high-pressure hydraulic line burst sending several gallons of hydraulic fluid onto our driveway and then into our street. The tow truck driver and we went to work picking up the spilt fluid with absorbent material. We were able to capture most of the fluid, but there was a residual amount left in the street. I pondered who to call.

After searching on the City of Gresham's web site <https://greshamoregon.gov>, I found a phone number to call. The response by the city was remarkable. Gresham's Transportation Division crew members responded to our location with 45 minutes of our call. They laid down more absorbent material to help mitigate the remaining spill to prevent it from reaching our storm drains. Link: <https://greshamoregon.gov/Report-spills-or-illegal-dumping/>

Report Spills or Illegal Dumping

Hazardous spills

- Report hazardous spills by calling 911.

Non-hazardous spills

- To report spills of non-hazardous materials, call the City's Operations Center: 503-618-2626.
- After hours, call the non-emergency line: 503-823-3333.

Illegal dumping

- Report illegal dumping on private property to Code Compliance at 503-618-2463 or through My Gresham (<https://greshamoregon.gov/mygresham>)
- Report illegal dumping on public rights-of-way to Metro's Regional Illegal Dumping Patrol at 503-234-3000.

Erosion

- Report erosion concerns to 503-618-2525 or submit a report through My Gresham (<https://greshamoregon.gov/mygresham>)

It is important to note, the city will only respond to spills or illegal dumping that are on public land or public right of ways, such as streets, paths, sidewalks.

Special appreciation goes to Chris Yamnitsky and Kary Moore, both public utility workers of Gresham's Transportation Division, along with Field Operations Supervisor Doug Holley who coordinated the quick response and cleanup efforts.■

Neighborhood Tree Plan Outreach: An Opportunity for WENA Residents

Gresham's Urban Forestry Subcommittee will be engaging Neighborhood Associations and other neighborhood groups in a year-long process to develop Neighborhood Tree Plans. There are several stages in the process culminating in a collaborative tree canopy project and action planning steps for each neighborhood.



A Neighborhood Tree Plan is intended to help preserve and expand your neighborhood trees. The Plan will be customized to address the urban forestry related issues unique to the Wilkes East neighborhood. The City and Urban Forestry Subcommittee will work with your neighborhood to:

- Define tree-related goals
- Develop tree-related actions
- Determine a tree canopy target
- Identify activities and projects

We are in the first listening stage of this outreach effort and asking neighbors to provide their association and City with input on the following questions:

- What are two things you find valuable about urban forest canopy?
- What are the neighborhood tree-related needs and/or desires? (i.e. what resources are needed?)
- What do you know about your neighborhood canopy coverage and do you have any concerns about it?
- What activities or projects do you think would benefit the neighborhood, and would you be willing to participate in these? - For example: tree planting, tree maintenance, tree pruning assistance
- Who in your neighborhood who can help champion this effort?

Street Sweeping Resumes Now Through November

Residential streets are swept monthly March through November during daytime hours. If weather conditions or a holiday prevent sweeping a street as scheduled, it will be swept at the end of that month, if time permits.

2021 Street Sweeping Schedule - Wilkes East

Street sweeping keeps roads safe by removing debris, such as paper and leaves that may be an obstacle to pedestrians and bikes. Sweeping removes debris that clog stormdrains and reduces the amount of pollutants that collects on city streets.

Help us keep streets clear

Please put these items in your driveway the 2nd Monday: Garbage cans, Recycle carts, Cars, Boats, Campers, Basketball hoops.

Overhanging tree branches must be at least 12' above the street and 8' above the sidewalk. For tree trimming tips please visit <https://greshamoregon.gov/WorkArea/DownloadAsset.aspx?id=11198>. Keep vegetation from overhanging the curb

Streets and leaves don't mix

Don't blow or place leaves or yard debris in the street. This is a violation of City code. The City sweeps leaves that naturally fall or blow into the streets from nearby trees.

Arterial street sweeping

Transportation provides year-round sweeping of the City's arterial streets the third full week of each month, Monday through Friday, between 10:00 pm and 7:00 am.
