The developer of this project is Westlake Construction. Greg will keep a watch on this project. From the google view it looks like they will have to cut down a lot of trees.

Greg Hartung, May Clean up

WENA received grant money from Metro to pay for expenses that we incur for May clean up. Greg signed the agreement with Metro and submitted the W9 form. The flyers that need to be done should include that we cannot accept appliances, liquid, tires, auto parts, animal waste and chemicals. The dumpster is set to arrive on Friday and to be removed on Monday from the Moose Lodge.

Kris has contacted a metal recycling company owned by Leonardo and they will be in attendance.

Everyone that is dropping off will need to sign a letter of indemnity.

Someone from the county has done a survey of road and sidewalk problems and the intersection of NE 162nd and Sandy Blvd is at the bottom of the list. It could be 10 years from now before this intersection is fixed. There are 2 bus stops, no ADA ramps, street is full of potholes, and no sidewalks.

Gail Voge has resigned as secretary and Janet Unruh will take over.

Janet had a suggestion that we put the deadlines for the newsletter articles on the website.
