TRAFFIC CHANGES SLATED FOR **NE181ST AVE: SPRING 2009**



Ask any rush hour commuter traveling NE 181st Ave in Gresham and they'll tell you, traffic congestion between Interstate 84 and NE Halsey St is miserable. In fact at times, it's downright unbearable!

Frustrated commuters rejoice, change is coming! The City of Gresham Dept of Public Affairs has announced a plan to reduce traffic congestion on NE 181st Ave between NE Sandy Blvd and NE Halsev St.

The proposed changes are scheduled to begin spring 2009, and be completed before summer. Changes include installing new state-of-the-art computercontrolled traffic signals, improving the westbound right turn at NE San Rafael St, eliminating a crosswalk across NE 181st Ave, plus several other changes in hope of improving the flow of traffic along this particularly busy section of the NE 181st Ave corridor.

The Friends of Nadaka group participated in the INTEL-SOLV 'Clean & Green Project' in October with another cleanup at Nadaka Park. A large dumpster provided by SOLV, and an eager 27 adults and 8

youth volunteers continued the clearing project along NE Pacific St donating a total of 110 hours.

With awareness building to improve Nadaka Park three more cleanups are scheduled this winter: Sundays, December 7th, January 4th, and February 1st from 8:30AM to 3:00PM. Volunteers are needed and participants should bring their gloves and clippers, and dress for the weather.

For Earth Day, April 18th, Friends of Nadaka will again partner with SOLV for what will be one of the largest Earth Day projects in the nation. Many volunteers are needed for this event so sign up early to participate!

In addition Friends of Nadaka is applying to Metro for a 'Nature in the Neighborhood' matching grant. Grants range from \$2,500 to \$25,000 and applications must be submitted by early January. This project is in the planning stages and your help and ideas are welcome. Friends of Nadaka is seeking partners for this grant and the City of Gresham, Audubon, People for Parks, and St Aidan's Church have all agreed to participate.

2008 NEIGHBORHOOD CLEAN-UP HUGE SUCCESS! Beds, BBQ's, Even an Old Boat: Neighbors Dump their Junk!

With the peak of summer this

year came the Wilkes East Neighborhood Clean-Up. For the past 3 years, Wilkes East residents have enjoyed the convenient disposal of unwanted trash and yard debris at the annual July fund-raiser. Residents lined-up early for the three hour event held Saturday July 26th at HB Lee Middle School. Staffed by a dozen volunteers this year's event filled two industrial sized (40 cubic yard) dumpsters to capacity! One dumpster for Yard Debris and Wood Waste, the other dumpster dedicated to Bulky Waste (trash).

Disposed items included yard debris, furniture, beds, bbqs, carpet, garage trash, remodeling debris, lots of junk, windows and doors, even an old wooden boat!

Volunteer coordinator Brian Heerwagon said he was very impressed with the number of participants, as well as the quantity of debris. Heerwagon says he'd like to add more dumpsters and recycling to next year's event.

CURBSIDE RECYCLING CAMPAIGN

Gresham and local haulers are participating in a Residential Recycling Campaign to educate residents about recycling set-out practices for glass items and plastic bags.

The campaign involves teams of field staff from Portland State University's Community Environmental Services monitoring roll carts throughout Gresham just prior to collection on two consecutive weeks. The teams are checking for plastic bags, major contamination and misssorted glass. If contamination or miss-sorted glass is found, the monitors will leave an instructional flyer to remind residents on proper recycling preparation. Residents doing a great job with recycling may receive a "Way to Go" flyer in recognition for their efforts.


